

JOB TITLE: SCANNING COORDINATOR

REPORTS TO: STORE MANAGER

JOB FUNCTION: To ensure accurate, up-to-date prices, signage, classifications, and a smooth functioning scanning system.

DUTIES AND RESPONSIBILITIES:

- Make price changes in the database in an accurate and timely manner from information communicated by staff and category managers.
- Add and delete items, change items to on-sale or off-sale, from information communicated by staff members. Account for tax, food stamp, and classification status when adding items.
- Creation of shelf tags as needed for new products or price/cost changes.
- Maintain PLU's, price changes, sign requests, etc. for multiple departments.
- Resolution of pricing and/or signage discrepancies.
- Facilitate efficient and accurate communication with all staff members involved in pricing and signage.
- Schedule and generate reports for managers' needs not covered by supplier movement reports.
- Maintain scanning equipment. Learn the functions and capabilities of new equipment and continually look for areas that need improvement.
- Assist selected personnel in creating correct signage and shelf tags and in operating scanning equipment to update prices, products, and sale items.
- Create and distribute NCG promotional endcap signage per sale period.
- Maintain shelf table accuracy in SMS at store level and update as new items arrive or sell out when discontinued.
- Create PDF's of sale signs to send to Cornerstone for printing. Sort sale tags that come from Cornerstone by aisle, vendor/product for ease in placement on changeover day.
- Create holdover batches for Wellness and Grocery areas based on previous promo period sales requested by department managers and approved by category managers.
- Monitor the scanning systems between multiple locations and provide input for system improvement.
- Maintain and update procedures for scanning systems.
- Participate in an ongoing verification of store products for accuracy (price, vendor information, size, classifications, etc.).
- Execute physical sale signage updates by deadline on changeover day. Verify and update signs as necessary.
- Perform weekly Produce audits and update data and signs as necessary
- Perform department shelf tag audits as scheduled by the annual audit calendar. Communicate and execute changes as necessary.

SAFETY

- Emphasize safety and safe body mechanics in a fast-paced department; participate in corporate ongoing safety training.
- Be proactive in reducing work-related injuries; recognize and solve potentially hazardous situations, and/or bring to the attention of the Department Manager.

QUALIFICATIONS:

- Accuracy, with scrupulous attention to detail.
- Computer skills including Microsoft Office, POS systems, and SMS.
- Familiarity with Lakewinds product line and accuracy in identification of products.
- Communications skills writing, listening and giving clear instructions.
- Knowledge of laws/rules pertaining to taxes, food stamps, product discounts.
- Reliability.
- Demonstrates ability to work independently as well as part of a team.
- Participate in ongoing Scanning training for changes and updates to store systems and processes.

ESSENTIAL PHYSICAL REQUIREMENTS:

- Ability to communicate effectively with personnel at all levels within the organization, including customers.
- Ability to read, count and write; and accurately complete all documentation.
- Ability to do math computations to figure margins including addition, subtraction, division, fractions, decimals and percentages.
- Ability to freely access all areas of the store including offices, selling floor, stock areas, and walk-in coolers and freezers.
- Ability to travel to multiple work locations.
- Ability to operate office equipment including printers, sign trimmer, telephone, fax, computer, handheld units, and peripherals repeatedly and for prolonged periods.
- Ability to move or handle merchandise throughout the store generally weighing up to 50 pounds.
- Ability to perform the following movements used in auditing shelf stock repeatedly and for sustained periods: walking, standing, bending, stooping, and reaching.
- Ability to work varied hours and days to ensure consistent, daily scanning coverage per store manager's expectations.
